

Tax Character of Distributions for 2025

The U.S. federal tax character of the distributions paid by PennantPark Investment Corporation (the “Company”) for calendar year 2025 is set forth in the table below. Distributions that were reinvested through the Company’s dividend reinvestment plan are treated, for tax purposes, as if they had been paid in cash. Therefore, stockholders who participate in the dividend reinvestment plan should also refer to the above table.
